This License Agreement (LICENSE) is a legal agreement between you (either an individual or a single business entity) and the manufacturer, Nonlinear Ideas, Incorporated (NLI) for the software product identified above, which includes computer software, source code, documentation, and associated media (SOFTWARE). By purchasing, installing, and using the SOFTWARE, you agree to be bound by the terms of this LICENSE. If you do not agree to the terms of this LICENSE, do not purchase, install, or use the SOFTWARE.

The SNMP MIB Parser (PARSER) is distributed as a Dynamic Link Library (DLL), along with a library file for compiling against, and a header file containing definitions of the function interfaces to the library. The SOFTWARE also includes the source code for the SNMP MIB Parser Demo (DEMO CODE) application.

This LICENSE is broken into three sections. The first section, SOFTWARE LICENSE, defines the legal agreements for the entire SOFTWARE distribution, INCLUDING the PARSER and the DEMO CODE. The second section, PARSER LICENSE, defines the legal agreements for the PARSER. The third section, DEMO CODE LICENSE, defines the legal agreements for the DEMO CODE. The SOFTWARE LICENSE agreements

SOFTWARE LICENSE

1. **COPYRIGHT.** The SOFTWARE is owned by NLI and is protected by United States copyright laws and international treaty provisions. Portions of the SOFTWARE copyrighted by other individuals or organizations have separate license agreements.
2. **PROPRIETARY RIGHTS.** All copyright, patent, trade secret, trademarks and other intellectual and property rights in the SOFTWARE are and shall remain the valuable property of NLI. You agree to take all necessary steps to ensure that the provisions of this agreement are not violated by you or by any person under your control or in your service.
3. **EXPORT RESTRICTIONS.** You agree that neither you nor your customers intend to or will, directly or indirectly, export or transmit (a) the SOFTWARE or (b) your APPLICATIONS or service that is the direct product of the SOFTWARE, to any country to which such export or transmission is restricted by any applicable U.S. regulation or statute, without the prior written consent, if required, of the Bureau of

Export Administration of the U.S. Department of Commerce, or such other governmental entity as may have jurisdiction over such export or transmission.

4. MISCELLANEOUS. If you acquired this product in the United States, the laws of the State of Texas govern this LICENSE. If this product was acquired outside the United States, then local law may apply. PARSER LICENSE

1. GRANT OF LICENSE. This LICENSE grants you the following rights and limitations:
 - a. Software Product. NLI grants to you a nonexclusive license to use the PARSER for the sole purposes of designing, developing, and testing your software components or applications (APPLICATIONS).
 - b. You may distribute these APPLICATIONS throughout your organization, making as many copies of the PARSER components as necessary for all your APPLICATION to be used in your organization.
 - c. You may NOT sell, lease, rent, sublicense, or distribute (i.e. give away) these APPLICATIONS, or their output, in part or whole. [For example, you MAY create an application using the PARSER which communicates with SNMP enabled equipment your company owns. However, you MAY NOT create an application and use it to communicate with SNMP enabled equipment owned by another company. By doing so, you are effectively renting the PARSER to another company for use (as far as this LICENSE is concerned). If you wish to use the PARSER to provide services to companies outside your own, you must purchase a DISTRIBUTION license.]
 - d. You may NOT sell, lease, rent, sublicense, or distribute the PARSER.
 - e. You may not reverse engineer, decompile, or disassemble the PARSER.
 - f. A copy of this license agreement must be included with all distributions of the APPLICATIONS.

DEMO CODE LICENSE

1. GRANT OF LICENSE. This LICENSE grants you the following rights and limitations:
 - a. Source Code. NLI grants you the nonexclusive license to use the DEMO CODE for the sole purpose of designing and developing your software applications (APPLICATIONS) which use the PARSER. The license agreements for these APPLICATIONS are covered in the PARSER LICENSE section of this LICENSE.
 - b. You MAY NOT distribute or disseminate the SOURCE CODE, in whole or in part. [You can't give it away, nor can you post it in news groups or other public media, outside of your company. The source code is given away as a demonstration to help you build applications with the PARSER, not as a product for you to resell.]
 - c. You MAY NOT sell, rent, lease, or sublicense the application which the SOURCE CODE builds. [If you wish to do so, purchase a distribution license.]
 - d. You MAY use the application that the SOURCE CODE builds, or an application derived from it, within your company. [Like the PARSER, you can build an application that you use in your company and on your company's equipment, but not on equipment owned by another company.]
